**FGC-OS SOFTWARE LICENSE AGREEMENT**  
**United States Only**  
**Single-Use License**

THIS SOFTWARE LICENSE AGREEMENT (the “**LICENSE**”) IS BETWEEN DIGITAL AEROLUS, INC., ITS SUCCESSORS AND ASSIGNS (the “**COMPANY**”) AND **YOU** AS PURCHASER OF THE DA DEVICE. PLEASE READ THIS LICENSE CAREFULLY BEFORE USING YOUR DA DEVICE. BY USING YOUR DA DEVICE YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, DO NOT USE THE DA DEVICE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, YOU MAY RETURN THE DA DEVICE FOR A REFUND WITHIN 14 DAYS AFTER YOU RECEIVE THE DEVICE.

**1. General - License Grant.**

(a) The software (including Folded Geometry™ Flight Code, embedded software, and third-party software), documentation, interfaces, content, and any data that came with your DA Device (“**Original FGC-OS Software**”), as may be updated or replaced by feature enhancements, software updates or system restore software provided by the Company (“**FGC-OS Software Updates**”), whether in read-only memory, on any other media or in any other form (the Original FGC-OS Software and FGC-OS Software Updates are collectively referred to as the “**FGC-OS Software**”) are licensed, not sold, to you by the Company for use only under the terms of this License. The Company and, if applicable, its licensors retain ownership of the FGC-OS Software itself and reserve all rights not expressly granted to you.

(b) The Company, at its discretion, may make available future FGC-OS Software Updates. The FGC-OS Software Updates, if any, may not necessarily include all existing software features or new features that the Company releases for newer or other models of DA Devices. The terms of this License will govern any FGC-OS Software Updates provided by the Company, unless such FGC-OS Software Update is accompanied by a separate license, in which case you must agree to the terms of that license (an “**Update License**”) at the time of the update.

**2. Permitted License Uses and Restrictions.**

(a) Subject to the terms and conditions of this License, you are granted a limited non-exclusive license to use the FGC-OS Software on a single DA Device within the United States of America and its Territories. Except as permitted in Section 2(b) below, and unless as provided in a separate agreement between you and the Company, this License does not allow the FGC-OS Software to exist on more than one DA Device at a time, and you may not distribute or make the FGC-OS Software available over a network where it could be used by multiple devices (whether another DA Device or other device) at the same time. This License does not grant you any rights to use any proprietary interfaces and other intellectual property in the design, development, manufacture, licensing, or distribution of third-party devices and accessories, or third-party software applications, for use with FGC-OS Devices.

(b) Subject to the terms and conditions of this License, you are granted a limited non-exclusive license to download FGC-OS Software Updates that may be made available by the

Company to update or restore the software on your DA Device. This License does not allow you to update or restore any DA Device that you do not control or own, and you may not distribute or make the FGC-OS Software Updates available over a network.

(c) You may not, and you agree not to or enable others to, copy (except as expressly permitted by this License), decompile, reverse engineer, disassemble, attempt to derive the source code of, decrypt, modify, or create derivative works of the FGC-OS Software or any services provided by the FGC-OS Software or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law or by licensing terms governing use of open-source components that may be included with the FGC-OS Software).

(d) Title and intellectual property rights in and to any content displayed by, stored on, or accessed through your DA Device belong to the respective content owner. Such content may be protected by copyright or other intellectual property laws and treaties, and may be subject to terms of use of the third-party providing such content. Except as otherwise provided herein, this License does not grant you any rights to use such content nor does it guarantee that such content will continue to be available to you.

(e) You agree to use the FGC-OS Software in compliance with all applicable laws, including local laws of the country, state, or region in which you reside or in which you download or use the FGC-OS Software.

**3. Transfer.** You may not rent, lease, lend, sell, assign, redistribute, or sublicense the FGC-OS Software. You may, however, make a one-time permanent transfer of all of your license rights to the FGC-OS Software to another party in connection with a transfer of ownership of your DA Device, provided that: (a) the transfer must include your DA Device and all of the FGC-OS Software, including all its component parts and this License; (b) you do not retain any copies of the FGC-OS Software or FGC-OS Software Updates, full or partial, including copies stored on a computer or other storage device; and (c) the party receiving the FGC-OS Software reads and agrees to accept the terms and conditions of this License.

**4. Termination.** This License is effective until terminated. This Agreement and your rights under this License will terminate automatically and cease to be effective without notice from the Company if you fail to comply with any term or terms of this License. Upon the termination of this License, you shall cease all use of the FGC-OS Software. Sections 4, 5, 6, 7, 9, and 10 of this License shall survive any such termination.

### **5. Disclaimer of Warranties.**

(a) If you are a customer who is a consumer (someone who uses the FGC-OS Software outside of your trade, business or profession), you may have legal rights in your country or state of residence that would prohibit the following limitations from applying to you, and where prohibited, they will not apply to you. (b) YOU EXPRESSLY ACKNOWLEDGE AND AGREE THAT, TO THE EXTENT PERMITTED BY APPLICABLE LAW, USE OF THE FGC-OS SOFTWARE AND ANY SERVICES PERFORMED BY OR ACCESSED THROUGH THE FGC-OS SOFTWARE IS AT YOUR SOLE RISK AND THAT THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, ACCURACY, AND EFFORT IS WITH YOU.

(c) TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, THE FGC-OS SOFTWARE AND SERVICES ARE PROVIDED "AS IS" AND "AS AVAILABLE", WITH ALL FAULTS AND WITHOUT WARRANTY OF ANY KIND, AND THE COMPANY HEREBY DISCLAIMS ALL WARRANTIES AND CONDITIONS WITH RESPECT TO THE FGC-OS SOFTWARE AND SERVICES, EITHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES AND/OR CONDITIONS OF MERCHANTABILITY, SATISFACTORY QUALITY, FITNESS FOR A PARTICULAR PURPOSE, ACCURACY, QUIET ENJOYMENT, AND NON-INFRINGEMENT OF THIRD PARTY RIGHTS.

(d) THE COMPANY DOES NOT WARRANT AGAINST INTERFERENCE WITH YOUR ENJOYMENT OF THE FGC-OS SOFTWARE AND SERVICES, THAT THE FUNCTIONS CONTAINED IN, OR SERVICES PERFORMED OR PROVIDED BY, THE FGC-OS SOFTWARE WILL MEET YOUR REQUIREMENTS, THAT THE OPERATION OF THE FGC-OS SOFTWARE AND SERVICES WILL BE UNINTERRUPTED OR ERROR-FREE, THAT ANY SERVICE WILL CONTINUE TO BE MADE AVAILABLE, THAT DEFECTS IN THE FGC-OS SOFTWARE OR SERVICES WILL BE CORRECTED, OR THAT THE FGC-OS SOFTWARE WILL BE COMPATIBLE OR WORK WITH ANY THIRD-PARTY SOFTWARE, APPLICATIONS OR THIRD-PARTY SERVICES. The foregoing limitations will apply even if the above stated remedy fails of its essential purpose.

**7. Compliance with Laws; Export Control.** You must use the DA Device in compliance with all applicable laws. You may not use or otherwise export or re-export the FGC-OS Software outside of the United States of America and its Territories. You agree that you will not use the FGC-OS Software for any purposes prohibited by United States law, including, without limitation, the development, design, manufacture, or production of missiles, nuclear, chemical, or biological weapons.

**8. Government End Users.** The FGC-OS Software and related documentation are "Commercial Items", as that term is defined at 48 C.F.R. §2.101, consisting of "Commercial Computer Software" and "Commercial Computer Software Documentation", as such terms are used in 48 C.F.R. §12.212 or 48 C.F.R. §227.7202, as applicable. Consistent with 48 C.F.R. §12.212 or 48 C.F.R. §227.7202-1 through 227.7202-4, as applicable, the Commercial Computer Software and Commercial Computer Software Documentation are being licensed to U.S. Government end users (a) only as Commercial Items, and (b) with only those rights as are granted to all other end users pursuant to the terms and conditions herein. Unpublished-rights are reserved under the copyright laws of the United States.

**9. Controlling Law and Severability.** This License will be governed by and construed in accordance with the laws of the State of Kansas, United States of America, without reference to any provisions or principles thereof that would require the application of the laws of a different jurisdiction, and the same will govern any dispute, controversy, or claim arising from or relating to this Agreement, including the existence, invalidity, performance, breach, or termination hereof. You further consent to exclusive jurisdiction and venue in the state and federal courts sitting in the State of Kansas. If for any reason a court of competent jurisdiction finds any provision, or portion thereof, to be unenforceable, the remainder of this License shall continue in full force and effect.

**10. Complete Agreement; Governing Language; Assignment.** This License constitutes the entire agreement between you and the Company relating to the FGC-OS Software and supersedes all prior or contemporaneous understandings regarding such subject matter. Your purchase and use of the DA Device will be subject to Company's terms of sale (or similar agreement) which are in addition to, and not superseded by, this License. No amendment to or modification of this License (other than an Update License) will be binding unless in writing and signed by an authorized representative of the Company. This License may be assigned by Company without your consent.

**11. Third Party Acknowledgements.** Portions of the FGC-OS Software may utilize or include third-party software and other copyrighted material. Acknowledgements, licensing terms, and disclaimers for such material are contained in the electronic documentation for the FGC-OS Software, and your use of such material is governed by their respective terms. Your DA Device may be sold with components or devices provided by third parties ("**Third Party Devices**") and to the extent authorized and necessary the Company is hereby transferring to you any software

licenses and other ownership rights associated with those Third Party Devices. You agree to the requirements for operating the Third Party Devices and accept the transfer of any applicable licenses associated with the Third Party Devices in connection with the transfer of ownership of the Third Party Devices. You acknowledge that your use of the Third Party Devices may result in charges to you, for which you will be solely responsible. The Company makes no representations regarding any third party's use of any data it receives as a result of your use of the Third Party Device.
